

FAQs

- **Is my company eligible to participate in the business/corporate tax credit program?** *If your company files taxes as 'C' or 'S' corporation in Arizona OR is an insurance company that pays a premium tax, your company is eligible.*
- **How much can my company contribute?** *Whatever amount you like. This is paying your AZ state taxes indirectly so there is NO NET cost. However, the max you can claim is not more than your total tax liability or state premium tax obligation, for the (fiscal) tax year.*
- **Can our company recommend who may receive a scholarship?** *Yes. A recommendation can be made for one or more K-12 qualified private schools in Arizona but not for specific students.*
- **What percentage is disbursed as a scholarship?** *90-95% is awarded as tuition scholarships to eligible low income or disabled students at K-12 qualified private schools.*

CORPORATE TAX CREDITS

In 2006 the Arizona Corporate School Tuition Tax Credit Law **ARS §43-1183** was passed. Two years later the Corporate Disabled/Displaced School Tuition Tax Credit Law **ARS §43-1184** was passed.

This allows businesses that file as C-corporations, S-corporations* and insurance companies in Arizona to contribute to AZ4Education and receive a dollar-for-dollar tax credit towards your Arizona state tax liability or premium tax owed.

Arizona corporate tax credit maximum caps for the 2 different tax credits are as follows.

FY	Low Income	Disabled/Displaced
21-22	\$135.3 M**	\$5 M
22-23	\$142.1 M**	\$5 M
23-24	\$144.9 M**	\$5 M

Contribution amounts are subject to a preapproval process with ADOR. Amounts are considered by ADOR on a **first come, first serve basis**.

****S-Corp must contribute a minimum of \$5,000. Can pass the tax credit through to shareholders or partners and claim a pro rata share of the credit.***

***** Fiscal year starts July 1.***

HOW IT WORKS

Your business or insurance company notifies AZ4Education that you intend to make a tax credit contribution, aka a "pledge". The amount can be as much as your state revenue tax liability or insurance premium tax for the current tax year.

AZ4Education then sends a request to ADOR for preapproval of your pledged contribution amount.

ADOR will reply within 20 calendar days. If the state tax credit cap has not been met, the request is approved. All requests are processed on a **first come, first serve basis**.

If approved by ADOR, AZ4Education will contact your company that day to provide information on transferring your pledged contribution amount. The funds must be received by AZ4Education within 20 calendar days of ADOR approval or everything resets.

We can accept your pledge anytime, but the start date for submission to ADOR (by Az4Education) occurs in the 1st week in July.

Your company may also carry any unused credit forward for up to five (5) years.

With your tax credit contribution, more students can get the type of education they desire in Arizona!
