FAQs

 How much can I donate? Any amount is appreciated and makes a difference, but the max tax credit you can claim is the lesser of your tax liability or tax credit limit shown below. Note: You can carry any unused credit forward, up to five years.

- Can I recommend my donation be considered for a school or student? Yes. However, final scholarship decisions are made by AZ4Education based on eligibility.
- If I am getting a refund, can I still give? Yes. The amount of your refund will increase by the amount of your donation as long as your total tax credit does not exceed your state income tax obligation.
- Can my employer participate? Yes. We can do matching, payroll deduction, and more. Please see our web site or contact us for information on how your employer can participate.

The Arizona Private School Tax Credit Law, A.R.S. §43-1089, allows you as an Arizona taxpayer to make a donation to AZ4Education and receive a dollar-fordollar credit towards your Arizona tax obligation.

This means if you owe money, you subtract the amount of your contribution from what you owe. If you are receiving a refund, it will increase by the amount of your contribution.

This gives you a say in where your income taxes are used and directly helps Arizona students, teachers, school staff, community, and tax payers.
