- **How much can I donate?** *Any amount is appreciated and helps make a difference. Since you are donating to a 501(c)(3) nonprofit, it can be claimed as a charitable deduction when you file. Please consult with your tax advisor.*
- **Can I recommend my donation be considered for a school or student?** *Yes. However, final scholarship decisions are made by AZ4Education. Scholarships are awarded without regard to a student's religion, race, color, handicap, familial status, or national origin.*
- **Am I able to take a deduction on my Fed Tax Form?** *Yes. AZ4Education is a 501(c)(3) nonprofit. Please consult with your tax advisor.*
